INSTRUCTIONS

- 1. Read and sign the Terms & Conditions on the next page.
- 2. Fill in all the required fields on the Custom Information Sheet
- 3. Place damaged propeller or gear case as well as the signed Terms & Conditions and Customer Information sheets into a new, undamaged cardboard box. Be sure the pack the box so as to prevent damage to its contents.
- 4. Send the box via Canada Post or by courier to the following address:

- 5. Upon receipt of your damaged item, Deano's Prop Repair will process it in the order in which it was received. Before completing any work, we will contact you via Telephone and request payment information. We accept Visa & Mastercard for payment. No cash or cheques will be accepted.
- 6. After the repair is complete, Deano's Prop Repair will charge the credit card you have provided us with, and return the item to the address you have provided us. We reserve the right to charge an additional Shipping & Handling fee to cover the return shipping cost.

Deano's Prop Repair offers a mail-in propeller and gear case repair service. To take advantage of this service, you must agree to abide by the following terms and conditions:

- 1. Mail-in repairs are accepted from all addresses within Canada. Customers outside of Canada are not eligible for this service.
- 2. Deano's Prop Repair can repair most types of consumer-grade, residential watercraft propellers constructed of Stainless Steel, Aluminum, and Nibril, as well as gear cases from most residential watercraft. If you are not sure of your item's construction or eligibility for this service, please Contact Us before taking advantage of this service.
- 3. Some types of damage are not repairable and require a replacement. While Deano's will make every effort to repair propellers and gear cases sent to us, we cannot guarantee any propeller or gear case can be repaired. Please Contact Us if you are not sure if your propeller or gear case can be repaired.
- 4. You are responsible for all shipping charges levied by Canada Post or courier service, including return shipping. This includes ineligible or unrepairable items that you send to us.
- 5. You acknowledge that if you fail to pay all shipping & repair costs within thirty days of Deano's Prop Repair requesting payment, you surrender ownership of the item. If Deano's Prop Repair is unable to contact you within sixty days, the item will be considered abandoned.
